

#### Hybrid Model and All Virtual Model



## What is the Hybrid Model? (Cohorts A and B)

- Students are assigned to either an A or B Cohort (by household)
- The A Cohort attends in person on M,T
- The B Cohort attends in person on Th,F

## What is the Virtual Model? (Cohort C)

 Students are assigned to either an A or B cohort and attend school virtually.



Wednesday is a deep cleaning day and all students learn from home for the entire day district wide; no students

Attend in person this day

### Synchronous Learning



- Synchronous learning happens in real time
- The student and instructor interact in a specific virtual place, through a specific online medium, at a specific time.
- Methods of synchronous online learning include video conferencing, teleconferencing, live chatting, and livestreaming lectures

#### Asynchronous Learning



- Happens on your schedule
- The teacher will provide materials for reading, lectures for viewing, assignments for completing, and exams for evaluation.
- Students have the ability to access and satisfy these requirements within a flexible time frame.
- Methods of asynchronous online learning occur within the Learning Management System and include self-guided lessons, streaming video content, games, virtual libraries, posted lecture notes, and exchanges across discussion boards.



## What does hybrid or virtual instruction look like in September at MACS?



• In order to maximize instructional time with students, teachers in Grades K-12 will broadcast their lesson to the students at home (all virtual students and the cohort learning from home that day will join the lesson) while they are teaching the lesson live to the in-person students. This provides 4 days of teacher led instruction for all students


#### Example:

A Cohort: M,T (in person) Th, F (student joins teacher led, live class, virtually from home)

**B Cohort:** Th, F (in person) M, T (student joins teacher led, live class, virtually from home)

C Cohort: (all virtual students) Follows same schedule as in person students and joins live, teacher led class M, T, Th, F

# What is the schedule for Pre-K students who are hybrid?



Students who are hybrid and assigned to a.m. Pre-k will be divided into an A and B cohorts

A cohort students attend ½ day a.m. M, T

B cohort students attend ½ day a.m. Th, F

Students who are hybrid and assigned to p.m. Pre-k will be divided into A and B cohorts

A cohort students attend ½ day p.m. M, T

B cohort students attend ½ day p.m. Th, F

On the days that students are learning from home, teachers will post resources/activities/teaching videos

#### Student Responsibilities



1

Students will be required to follow a specific schedule every day, whether they are learning in a hybrid or all virtual model

2

Daily attendance will be taken by teachers; students are expected to log-in to join their classes on time 3

Students will be expected to fully participate in classroom assignments and complete all assigned work each day

The benefit is 4 days of teacher led instruction for our students and less learning gaps during this challenging time

# Health and Safety: Daily Temperature Screening



- Transportation staff will take students' temperatures before they enter the bus, using an infrared forehead scanner
- If the student has a temperature of 100.0 or higher, they will not be permitted on the bus.
- Students who are being dropped off at school will have their temperature taken outside, prior to entering the building.
- Staff will participate in daily temperature screenings as well as completing a district COVID-19 screening form prior to starting their workday.
- If a student arrives late to school, they will have their temperature taken upon arrival.



### Health and Safety: Masks

Based on Department of Health and New York State Education guidance, MACS students will be required to wear masks when riding the bus, transitioning between classes or moving in the hallway, during arrival/dismissal in the buildings, and at any other time that 6 ft. of social distancing can't be maintained.


- Students are permitted to bring their own mask to school every day....must be school appropriate. No scarves or bandanas
- If the student does not have a mask, a disposable mask will be provided by the district.
- During classroom instruction, students will be permitted to remove their masks while seated or take regularly scheduled mask breaks.
- Since the health and safety of our learning community is our most important focus during this time, the district is requiring a doctor's note indicating the medical necessity for an exemption from mask wearing (as per Department of Health regulations).
- If a doctor's note is not provided, students must follow district mask wearing protocols.
- Students who refuse to comply with district mask wearing requirements will be assigned to virtual learning from home.



### Social Distancing



The New York Education
Department is requiring schools
to adhere to 6 feet of social
distance between students when
they are not wearing a mask,
and 12 feet of social distance
for special areas such as Physical
Education and Music.



### Social Distancing



#### Classrooms:

Every classroom in the district has been measured to assure 6 feet of social distance exists between all student desks and the teacher desk. Due to this requirement, classrooms are limited to an average of 12 students per room.

#### Hallways:

Visual aids will be used in our buildings to illustrate traffic flow with appropriate social distance.

#### **Arrival/Dismissal:**

Each building will provide families with specific information regarding designated areas for student drop-off and pick-up, as well as arrival dismissal procedures

#### Social Distance on the Bus



- Students will be permitted to sit in a seat with members of their household
- With the seat as a barrier and separation of students, the bus has the capacity for 1 driver, 1 monitor, and 21 student riders at one time.



### Cleaning Protocols

- Student desks will be disinfected between all class transitions.
- Hand sanitizer will be available in teacher classrooms and designated areas in each building.
- Disinfecting wipes will be available in each classroom
- The district is implementing all ventilation/filtration requirements recommended in the NYSED guidance document.
- Daily cleaning/disinfecting protocols have been established for bathrooms, shared areas, and high touch areas within every building.
- Enhanced cleaning will take place every Wednesday, when all students will be participating in virtual learning.
- Bus seats and high touch surfaces will be cleaned/disinfected between bus runs.
- Bathroom hand dryers will be disabled, and paper towel will be provided.
- No touch bottle fillers will be enabled on drinking fountains- please sendstudents with their own, labeled water bottle. Paper cups will also be provided to be used as need



## Specials/Recess/Extracurricular Activities/Sports




- The New York State Public High School Athletic Association (NYSPHSAA) has voted to pause the official start date of the Fall 2020 sports season until Monday, September 21st.
- Extracurricular activities and being evaluated for the potential to offer them virtually- no in person extracurricular activities will be offered at this time.
- Building principals and teachers are working together to create a schedule that incorporates physical education, music, band, and chorus opportunities for students both in person and virtual
- We are currently working with the YMCA to offer the elementary SACC program and anticipate being able to offer it to hybrid students on the days they attend school
